Call to Order:

Vanessa Rakestraw, Vice Chair, called the meeting to order at 10:35 a.m.

Introductions:

The Board members, Program staff and counsel introduced themselves to Mr. and Mrs. Jeffer.

Minutes:

Senior Assistant Attorney General Collins suggested a minor revision. Chairman Schulwolf moved that the minutes be approved with the requested revisions by counsel. Dr. Filla seconded the motion and it passed unanimously.

Finance:

Deputy Director Thomas reported that there were two new admitted claimants with a total of 156 active claimants admitted into the Program through the end of April. Deputy Director Thomas stated that as of April 30, 2017, the Program had \$449 million in investments, as compared to \$404 million during the same period the previous year.

Investments:

Investment returns as of May 31st were 1.1% for the month and 5.9% for year to date due to higher returns in International Funding and Emerging Markets. Investments

totaled approximately \$453M. Rebalancing of funds has been implemented. Chairman Schulwolf moved that the Financial and Investment Reports be approved. Dr. Filla seconded the motion and it passed unanimously.

Public Comment:

Mr. and Mrs. Jeffer provided information to the Board concerning a request for housing modifications.

New Business:

Proposed revisions to the Program's Guidelines will be made to conform the Guidelines to the Governor's 2017 Budget Amendment.
